# ORDER OF DENIAL OF REINSTATEMENT OF MEDICATION TECHNICIAN CERTIFICATE

#### I. PROCEDURAL BACKGROUND

By default final order dated November 18, 2019, the Maryland Board of Nursing (the "Board") suspended the certificate of Nya Na'Rae Leatherbury (the "Respondent") to practice as medication technician ("MT"), certificate number MT0108078, in the State of Maryland, based on violations of the Maryland Nurse Practice Act, Md. Code Ann., Health Occ. §§ 8-101 *et seq.* (2014 Repl. Vol. & 2018 Supp.), specifically § 8-6A-10(a)(4) and (29) of the Health Occupations Article; *to wit*, Code of Maryland Regulations ("COMAR") 10.39.07.02C(2) and (12). The final order was based on the Respondent's 2019 criminal convictions for Malicious Destruction of Property/Value - \$1000 (crime involving moral turpitude), including one conviction related to malicious destruction of a client's property.

### II. CONSIDERATION OF REINSTATEMENT APPLICATION

On or about June 18, 2021, the Respondent submitted an electronic mail message to the Board stating that she submitted her MT renewal application and was requesting that the Board reinstate her certificate to practice as an MT in the State of Maryland.

The Board has reviewed and considered all information that the Respondent submitted in support of her application for reinstatement of her MT certificate, as well as all additional information in the Respondent's file. The Board notes the Respondent failed to provide the Board with any supporting documentation in support of her reinstatement request. Based upon

consideration of the Respondent's complete file, the Board finds that the Respondent has not met her burden of showing that she is a suitable candidate for reinstatement at this time. Before the Respondent's MT certificate is reinstated, the Board is requesting documentation of the Respondent's successful completion of an anger management course.

### III. ORDER

Based upon the foregoing, it is hereby:

**ORDERED** that Nya Na'Rae Leatherbury's application for reinstatement of her certificate to practice as a medication technician in the State of Maryland, certificate number MT0108078, is hereby **DENIED**; and it is further

ORDERED that this is a final order of the Maryland Board of Nursing and, as such, is a PUBLIC RECORD pursuant to Md. Code Ann., Gen. Prov. §§ 4-101 et seq. (2014).
