I. BACKGROUND

OF OCTOBER 9, 2015, ORDER OF PROBATION

On October 9, 2015, the Maryland Board of Nursing (the "Board") issued an "Order Granting Motion for Reconsideration and Order Vacating April 7, 2015 Order of Denial of Petition for Reinstatement of Registered Nursing License and Order of Reinstatement of Registered Nursing License/Order of Probation" (the "Probation Order"),¹ to Daniel Park (the "Respondent"), which placed the Respondent's license to practice registered nursing ("RN") in the State of Maryland, license number R167952, on probation for a minimum of five (5) years, subject to certain probation terms and conditions.² On October 22, 2020, the Respondent requested termination of the probationary status on the Respondent's RN license. On April 29, 2021, the Board denied the Respondent's request for termination of probation.

On July 13, 2021, the Respondent, by and through his attorney, submitted a "Motion for Partial Reconsideration of Denial of Request for Termination of Probation or, in the Alternative, for Modification of Order of Probation" (the "Motion"). Specifically, in the Motion, the

Order Granting Motion for Partial Reconsideration of Denial of Request for Termination of Probation and Order of Modification of October 9, 2015, Order of Probation

Respondent requested that the Probation Order be modified to permit the Respondent to submit alternative documentation to verify his attendance at Alcoholics Anonymous or Narcotics Anonymous meetings, *i.e.*, an affidavit with his quarterly self-reports. The Probation Order currently requires that the Respondent "shall submit documentation, such as signed attendance slips, verifying his attendance, twice per week, at either Alcoholics Anonymous or Narcotics Anonymous meetings" (the "Meeting Documentation Requirement"). (Probation Order, p. 5).

Upon consideration of the Respondent's request for modification, and after a review of the Respondent's probation compliance file, the Board hereby grants the Respondent's Motion and modifies that condition of the Probation Order to permit the Respondent to submit an affidavit to verify his attendance at Alcoholics Anonymous or Narcotics Anonymous meetings, on a quarterly basis with the Respondent's required written self-reports, in lieu of signed attendance slips (a/k/a sign-in sheets).

II. ORDER

Based upon the foregoing, it is hereby:

ORDERED that the Probation Order's Meeting Documentation requirement is hereby **MODIFIED** to permit the Respondent to submit a signed affidavit, in lieu of signed attendance slips, attesting to his attendance, twice per week, at either Alcoholics Anonymous or Narcotics Anonymous meetings, on a quarterly basis with his written self-reports; and it is further

ORDERED that all remaining terms and conditions set forth in the Probation Order, as modified or terminated via the Modification Orders, remain in full force and effect; and it is further

I. PROCEDURAL BACKGROUND

On August 21, 2013, Daniel Park was expelled from the Maryland Board of Nursing's Rehabilitation Program for non-compliance with the participation agreement that the Petitioner signed on February 15, 2012. In an effort to resolve the matter prior to the issuance of formal disciplinary charges against his license to practice as a registered nurse ("RN"), Mr. Park signed a letter offering to surrender his RN license. On August 27, 2013, the Maryland Board of Nursing (the "Board") accepted Mr. Park's letter of surrender pursuant to Md. Code Ann., Health Occ. ("H.O.") § 8-314.

By letter dated August 21, 2014, Mr. Park formally applied for reinstatement of his license to practice as a registered nurse and sent in documents in support of his application for reinstatement of his RN license. The Board issued an Order of Denial of Petition for Reinstatement of Registered Nursing License ("Order of Denial") on April 7, 2015, which denied Mr. Park's application for reinstatement and prohibited him from re-applying for reinstatement for two years.

On May 6, 2015, Mr. Park filed a Motion for Reconsideration of Order of Denial of



Petition for Reinstatement of Registered Nursing License, and Request for Hearing ("Motion for Reconsideration"). In this Motion for Reconsideration, Mr. Park requested that the Board reconsider its Order of Denial and "reinstate his license on appropriate terms and conditions, including periodic, random drug testing, as the Board may require."

II. DISCUSSION

Following review of Mr. Park's Motion for Reconsideration, the Board has reconsidered its April 7, 2015 Order of Denial as well as the documents that Mr. Park submitted in support of his August 21, 2014 application for reinstatement. The Board will grant Mr. Park's Motion for Reconsideration and will reinstate Mr. Park's RN license subject to a five-year period of probation subject to terms and conditions.

III. ORDER

Based upon the foregoing, it is hereby:

1.

ORDERED that Daniel Park's Motion for Reconsideration of Order of Denial of Petition for Reinstatement of his Registered Nursing License, license number R167952, is hereby GRANTED; and it is further

ORDERED that the Board's April 7, 2015 Order of Denial of Petition for Reinstatement of Registered Nursing License is hereby **VACATED** and is no longer of any force or effect; and it is further

ORDERED that Daniel Park's license to practice registered nursing in the State of Maryland is hereby **REINSTATED**; and it is further

ORDERED that, beginning on the effective date of this Order, the license of the Respondent to practice as a registered nurse in the State of Maryland is placed on **PROBATION**

for a minimum of FIVE (5) YEARS subject to the following terms and conditions:

1. Mr. Park's status as a registered nurse will be listed in the Board's computer

records and website as being on "Probation";

7. Mr. Park shall arrange for his supervisor at his place of employment to submit written quarterly Work-Site reports to the Board evaluating his nursing practice. It is Mr. Park's responsibility to ensure that work-site reports are submitted to the Board and to notify his supervisor when these reports are due. An unsatisfactory report will be considered a violation of probation and this Order;

8. Mr. Park shall notify the Board in writing of any nursing position from which he is terminated and/or of any nursing position from which he voluntarily resigns within **THREE (3) BUSINESS DAYS** of the date of termination and resignation. The Respondent shall include the reasons for the termination or resignation in any written notification to the Board. Failure to provide written notification to the Board of any termination or resignation as required by this paragraph shall constitute a violation of probation and this Order:

9. Mr. Park shall submit to the Board <u>written monthly self reports</u> describing the his progress. Failure to provide written self reports on time shall constitute a violation of probation and this Order;

Mr. Park shall submit to random drug testing, at any time, of urine, breath, or blood 36-40 times per year for the first two (2) years of the probationary period as required by the Board and 24-30 times per year for the remainder of the probationary period¹ as required by the Board and cause the results to be submitted to the Board, and Mr. Park shall comply with the following drug-monitoring terms and conditions, including:

I. BACKGROUND

On October 9, 2015, the Board issued an "Order Granting Motion for Reconsideration and Order Vacating April 7, 2015 Order of Denial of Petition for Reinstatement of Registered Nursing License and Order of Reinstatement of Registered Nursing License/Order of Probation" ("Probation Order"),¹ which placed the Respondent's RN license on probation for a minimum of five (5) years subject to certain probationary terms and conditions.² Pursuant to the Probation Order, condition number 6, the Respondent "shall not work any night shifts." (Probation Order, p. 3). In July of 2018, the Respondent requested a modification of the Probation Order, specifically, that the Board lift condition number 6 and permit him to work night shifts. Upon consideration of the Respondent's request for modification, and after a review of the Respondent's probation compliance file, the Board hereby grants the Respondent's request and lifts and terminates condition number 6 of the Probation Order, which prohibits the Respondent from working night

I. PROCEDURAL BACKGROUND

On August 21, 2013, Daniel Park was expelled from the Maryland Board of Nursing's Rehabilitation Program for non-compliance with the participation agreement that the Petitioner signed on February 15, 2012. In an effort to resolve the matter prior to the issuance of formal disciplinary charges against his license to practice as a registered nurse ("RN"), Mr. Park signed a letter offering to surrender his RN license. On August 27, 2013, the Maryland Board of Nursing (the "Board") accepted Mr. Park's letter of surrender pursuant to Md. Code Ann., Health Occ. ("H.O.") § 8-314.

By letter dated August 21, 2014, Mr. Park formally applied for reinstatement of his license to practice as a registered nurse and sent in documents in support of his application for reinstatement of his RN license. The Board issued an Order of Denial of Petition for Reinstatement of Registered Nursing License ("Order of Denial") on April 7, 2015, which denied Mr. Park's application for reinstatement and prohibited him from re-applying for reinstatement for two years.

On May 6, 2015, Mr. Park filed a Motion for Reconsideration of Order of Denial of



Petition for Reinstatement of Registered Nursing License, and Request for Hearing ("Motion for Reconsideration"). In this Motion for Reconsideration, Mr. Park requested that the Board reconsider its Order of Denial and "reinstate his license on appropriate terms and conditions, including periodic, random drug testing, as the Board may require."

II. DISCUSSION

Following review of Mr. Park's Motion for Reconsideration, the Board has reconsidered its April 7, 2015 Order of Denial as well as the documents that Mr. Park submitted in support of his August 21, 2014 application for reinstatement. The Board will grant Mr. Park's Motion for Reconsideration and will reinstate Mr. Park's RN license subject to a five-year period of probation subject to terms and conditions.

III. ORDER

Based upon the foregoing, it is hereby:

ORDERED that Daniel Park's Motion for Reconsideration of Order of Denial of Petition for Reinstatement of his Registered Nursing License, license number R167952, is hereby GRANTED; and it is further

ORDERED that the Board's April 7, 2015 Order of Denial of Petition for Reinstatement of Registered Nursing License is hereby **VACATED** and is no longer of any force or effect; and it is further

ORDERED that Daniel Park's license to practice registered nursing in the State of Maryland is hereby **REINSTATED**; and it is further
