Please Read

The Joint Committee on Nurse Practitioners (JCNP) reviewed the following **NEW** agreements on **July 7, 2010**. **ADDENDUMS** received by **June 30, 2010**, are also listed and will go to the **Board of Nursing** for approval on **July 27, 2010**.

THE SUBMISSION DEADLINE WAS: JUNE 16, 2010

If you have submitted a new agreement or addendum and your name is NOT on the following list, your agreement or addendum may have been received after the above deadline and therefore will not be reviewed until **AUGUST 2010**.

If your name IS on this list, you must allow at least 14 business days after JCNP and Board meeting dates for receipt of temporary practice letters, final approval letters, request(s) for additional information or other notification(s) regarding your written agreement or addendum. *Please do not call or e-mail the Board regarding the status of your pending agreement unless you receive a request for additional information.* Should you receive a letter or request for additional information, call or email if you need clarification.

You CANNOT practice on your NEW AGREEMENT until you are in receipt of a temporary practice or approval letter (mailed within 14 business days of the Joint Committee (JCNP) meeting)

Important Note: Temporary practice letters do not allow you to apply for CDS privileges. Please do NOT attach your temporary practice letter to your application for CDS. The Division of Drug Control will not accept it. Letters granting Board approval for CDS are based on the terms of your collaborative agreement. Agreements approved for CDS will receive an approval letter that clearly states it should be attached to the CDS application.

You CANNOT practice on your ADDENDUM until you are in receipt of an Approval letter

Important Note: Addendums are not issued practice or approval letters until after the monthly Board meeting is held.
